Formal Recognition Order

1. WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 **MATUSHRI AHILIYADEVI TEACHERS EDUCATION INSTITUTE, 23-24, PRESS COMPLEX, A.B. ROAD, INDORE 452008 MADHYA PRADESH** has submitted an application (Code No.- APW00046/222019) to the Western Regional Committee of NCTE for grant of recognition/permission for conducting D.ED.course with an annual intake of 50 students on 31-Dec-02.

2.AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith , the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the ELE teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3.NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a)of the NCTE Act, 1993, the Western Regional Committee in its meeting decided to grants recognition / permission **MATUSHRI AHILIYADEVI TEACHERS EDUCATION INSTITUTE, 23-24, PRESS COMPLEX, A.B. ROAD, INDORE 452008 MADHYA PRADESH** for conducting D.Ed. course of ELE of 2 year duration with an annual intake of 50(ELE) for the academic session 2005-06 vide letter no. WRC/2-32/222019/78/2005/8163 dated 24/10/05 with a direction to submit the staff profile.

4. On the basis of approved staff profile submitted by the institutions, NOW THEREFORE , in exercise of the powers vested under section 14(3) a of the NCTE act 1993, the Western Regional Committee decided to issue formal recognition order to **MATUSHRI AHILIYADEVI TEACHERS EDUCATION INSTITUTE, 23-24, PRESS COMPLEX, A.B. ROAD, INDORE 452008 MADHYA PRADESH** for conducting D.Ed course of ELE of 2 year duration with an annual intake/additional of 50(ELE) under clause 7(11) of the NCTE (Recognition Norms & Procedure) regulation 2007. With this the total approved intake for the D.ED. course to the institution **MATUSHRI AHILIYADEVI TEACHERS EDUCATION INSTITUTE** becomes 100.

5. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into a joint account to be operated along with an officer of the Western Regional Committee.

6. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

7. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.

8. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
